

ARTICLES OF INCORPORATION

AM PRO SECURITY & SERVICES INC.

We, the undersigned, hereby associate ourselves for the purpose of becoming a corporation under the laws of the State of Florida and under the statue of the State of Florida for the formation, rights, privileges, immunities and liabilities of Incorporation for profit, it is:

ARTICLE I

THE NAME OF THE CORPORATION SHALL BE:

ARTICLE II

The corporation shall engage in any activity or business permitted under the laws of the State of Florida and of the United States of America.

ARTICLE III

The maximum number of shares which the corporation is authorized to issue shares of common stock, and and have outstanding at any time is 100 which common stock shall have a par value of \$5.00 stock is to be issued as fully paid and exempt from assessment.
