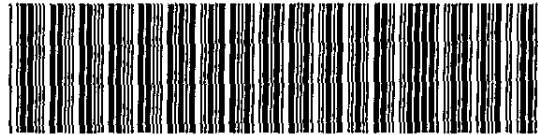

ARTICLE I – NAME

The Name of the Corporation is ROY'S ROOFIN, INC.

ARTICLE II

The duration of the corporation shall be perpetual. Existence of the corporation shall commence on the date of execution and acknowledgement of these articles.


