**ARTICLES OF AMENDMENT FOR NAME CHANGE**

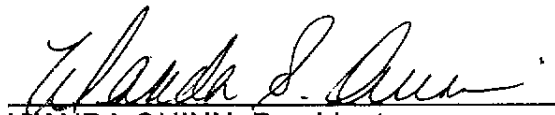

The name of the corporation shall be Go2Trade Corporation.

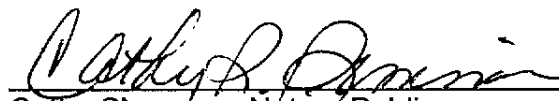
2. The foregoing amendment was adopted by the Stockholders and Directors of the corporation on the 28<sup>th</sup> day of December, 2004.
