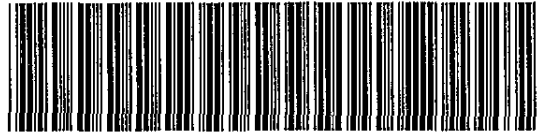



1. Introduction. James W. Hart, being duly sworn, deposes and says:




