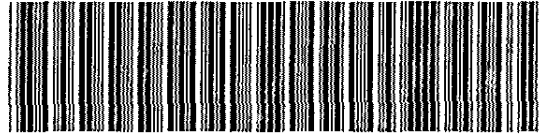

ARTICLES OF INCORPORATION

ARTICLE 1

Name: The name of the corporation is ALMIGHTY ASSOCIATES INC

ARTICLE 2

Duration: The period of duration of this corporation is perpetual.

ARTICLE 11


Amendments:
