ARTICLES OF INCORPORATION OF PRIORITY FREIGHT, INC.

The undersigned incorporator for the purpose of forming a corporation under the Florida Business Corporation Actor hereby Adopt the following Articles of Incorporation.

ARTICLE I -NAME
