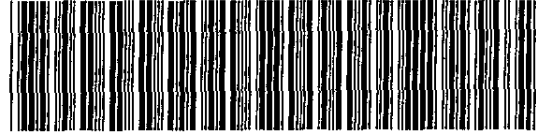

OF

ARTICLE I

The name of this corporation is AAJ Sprinklers, Inc.
