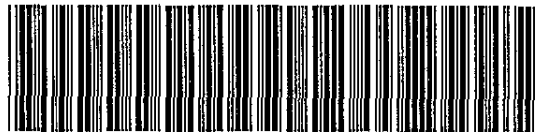

Of

##### Name

General Provisions


