The undersigned incorporator to these Articles of Incorporation hereby forms a corporation under the laws of the State of Florida as follows:

**ARTICLE I - NAME**

The name of the corporation is Social Splendor, Inc.

**ARTICLE II - TERM OF EXISTENCE**

The date when corporate existence shall commence shall be January 2, 2005 and the corporation shall have perpetual existence thereafter.

**ARTICLE III - PURPOSES**

This corporation is organized for any and all lawful purposes.

**ARTICLE IV - CAPITAL STOCK**

This corporation is authorized to issue one hundred (100) shares of one dollar (\$1.00) par value common stock which shall all be of one class of Common shares.


**ARTICLE X - INDEMNIFICATION**


