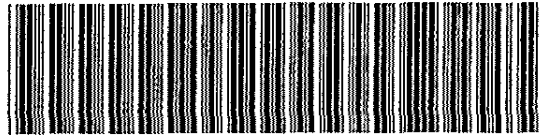

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following articles of incorporation:

ARTICLE I

The name of this corporation shall be: Roya Nouhi, P.A.

ARTICLE II

The purpose of purposes for which the corporation is organized is:

To engage in the transaction of any or all-lawful business of brokerage, sales, acquisitions, rentals, and other related activities of real estate, which corporations may be incorporated under the provisions of the Florida General Corporation Act.

The name and address of the initial Registered Agent is: Roya Nouhi, 270 Monteray Drive, Naples, Florida 34119.


ARTICLE VI
