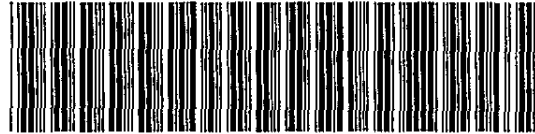

**ARTICLE OF INCORPORATION  
OF

**ARTICLE I: NAME**

The name of this corporation is A PLUS AUTO REPAIR, INC. The mailing address of the corporation is 12625 CHELMSFORD CT, ORLANDO, FL 32837.

**ARTICLE II: DURATION**

This corporation shall have perpetual existence.

**ARTICLE III: PURPOSE**
