In response to Notice of Administrative Dissolution for Imperial Floorcovering, Inc., we request reinstatement.

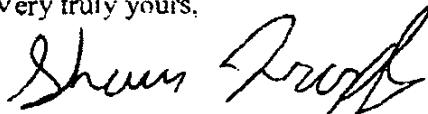
