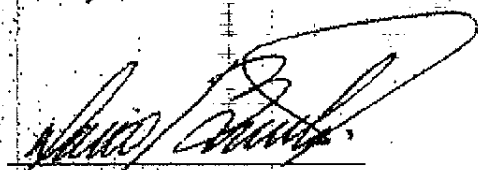
ARTICLE X - Liquidation

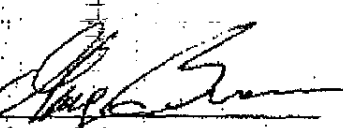
