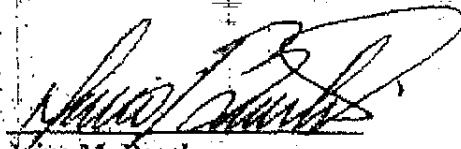
ARTICLE X - Liquidation

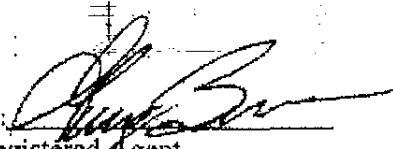

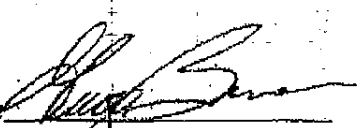
