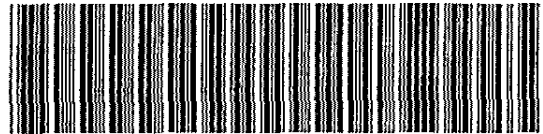

ARTICLES OF INCORPORATION
OF
RULAPAUGH PAINTING, INC.

ARTICLE I
NAME

The name of this corporation is RULAPAUGH PAINTING, INC.



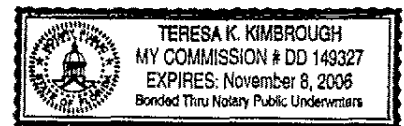


