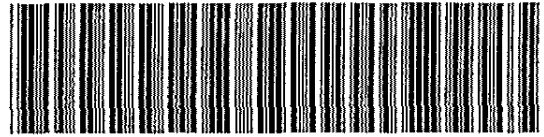



The name of this corporation shall be: CARDIOLOGY RESEARCH ASSOCIATES, INC.

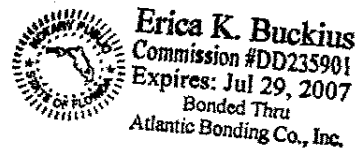


