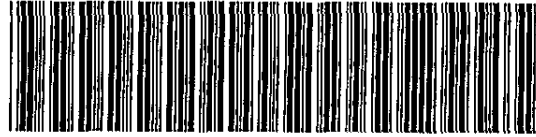

**ARTICLES OF INCORPORATION
OF
TUNNEL VISION MUSIC GROUP, INC.**

I, the undersigned, in order to form a corporation under and pursuant to the provisions of the Law of Florida for the purposes set forth below, hereby subscribed to these Articles of Incorporation.

I

The name of the corporation shall be: TUNNEL VISION MUSIC GROUP, INC.

II

The purposes and general nature of the business to be transacted by the corporation shall be as follows:

- A. To do and transact any and all business as permitted under the laws of the State of Florida and the United States of America.



At the discretion of the initial sole stockholder or the successor of all shares of the stockholder, or when there are two or more stockholders owning stock in the corporation, at a meeting held for that purpose stockholders may elect to operate with Board of Directors and officers as provided elsewhere in these Articles of Incorporation. The manner and form of electing or appointing officers and directors shall be set out in the By-Laws.


