### ARTICLES OF INCORPORATION OF Haynes Properties, Inc.

The undersigned, for the purpose of forming a corporation for profit pursuant to Chapter 607, Florida statutes, does hereby adopt the following Articles of Incorporation:

#### ARTICLE I. CORPORATE NAME

The name of this corporation is: Haynes Properties, Inc.

#### ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS

This corporation is authorized to issue 10,000 shares of \$1.00 par value common stock.
