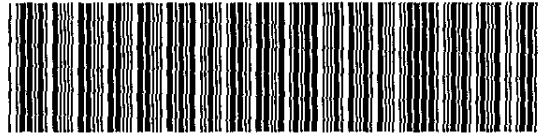

**ARTICLE I
NAME**

The name of the corporation is: SOUTHERN IRON CYCLES, INC. at
8709 Ethans Glen Terr., Jacksonville, FL 32256.

**ARTICLE II
DURATION**

This corporation shall have perpetual existence.

**ARTICLE III
PURPOSE**

This corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.



The corporate existence will be effective this date **November , 2004.**



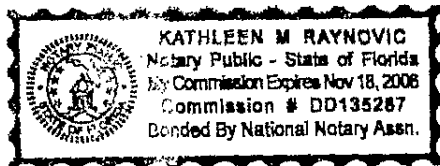
