ARTICLES OF INCORPORATION

OF

STRIDES Of South Florida, Inc.

The undersigned, acting as incorporator of STRIDES of South Florida, Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation. In compliance with chapter 621, F.S.

ARTICLE I. NAME

The name of the corporation is STRIDES of South Florida, Inc.

ARTICLE II. ADDRESS

ARTICLE III. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on the date of filing of these Articles of Incorporation.

ARTICLE V. AUTHORIZED SHARES

The name and street address of the incorporator is Raul E. Vega, 18314 S.W. 153rd Place Miami, Florida 33187.


ARTICLE VIII. BYLAWS


