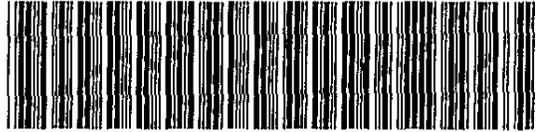

ARTICLE I - Name

The name of the corporation shall be: **MS LIZZY'S TESTING INC.**

ARTICLE II - Duration

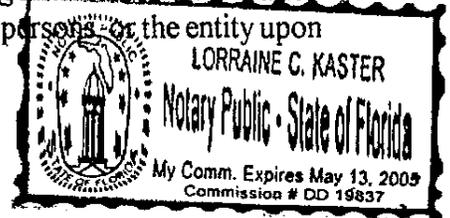
