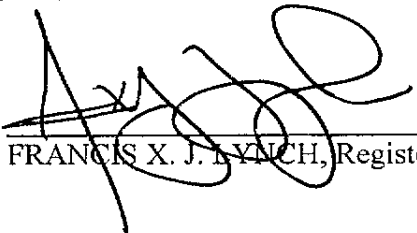
Pursuant to Section 607.0202, Florida Statutes, these Articles of Incorporation provide that:
