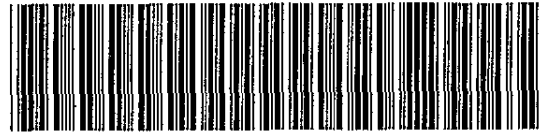

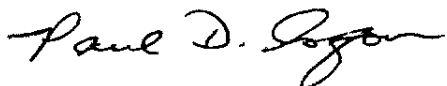

FOR
