ARTICLES OF INCORPORATION SERVICES OF RUSSELL POWERSPORTS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be RUSSELL POWERSPORTS, INC.

ARTICLE II PRINCIPAL OFFICE

The street address of the principal office is 5576 Doug Taylor Circle, St. James City, Florida 33956, and mailing address of this corporation shall be P.O. Box 301, Pineland, Florida 33945.

ARTICLE III CAPITAL STOCK

The aggregate number of shares which the corporation shall have authority to issue is SEVEN THOUSAND FIVE HUNDRED (7,500) SHARES, consisting of one class only designated as "common stock," with par value of \$1.00 per share.
