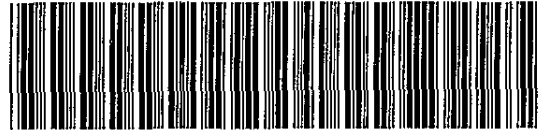

# **ARTICLES OF INCORPORATION**

### **ARTICLE 1 – NAME**
