**ARTICLES OF INCORPORATION  
OF  
FIVE WEST CORP.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation ("Corporation") is FIVE WEST CORP.

**ARTICLE II**

The existence of the Corporation shall begin on November 30, 2004.

**ARTICLE III**

**ARTICLE VI**


