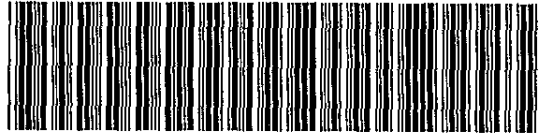

of

ARTICLE I

Name: The name of this corporation is Richardson-Morris Quarter Horses, Inc.

ARTICLE II

State of Incorporation: This corporation is hereby formed under the laws of the State of Florida.

ARTICLE III

Purposes and Powers: This corporation is organized for the transaction of any and all lawful business for which corporations may be incorporated under the laws of Florida, as they may be amended from time to time, and specifically but not in limitation thereof, for the purpose of training and boarding horses and related retail entities pertaining to the sale of feed, tack, and other equestrian-related materials. This corporation shall have the broad general powers set forth by regulation and statute in this state.

Duration: The duration of this corporation shall be in perpetuity.

Capital Stock: The authorized capital stock shall consist of 100 shares of common voting stock with a Par Value of \$1.00.





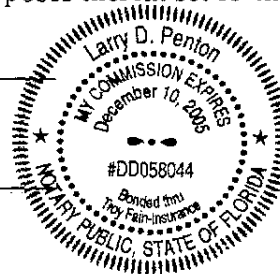
