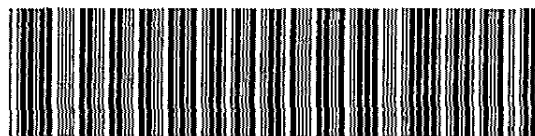

ARTICLES OF INCORPORATION

Article I – Name

The name of this corporation is: A 1 SWFL WILDLIFE SPECIALTIES, INC.

This corporation shall have perpetual existence.
