ARTICLES OF INCORPORATION

The undersigned subscriber(s) to these articles of incorporation, being duly licensed to practice optometry under the laws of the state of Florida, adopt(s) these articles to form a corporation under the Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621, and other laws of the state of Florida.

ARTICLE I - NAME

The name of the professional service corporation ("Corporation") is: KELLI G. GARCIA, O.D., P.A.

ARTICLE II - PRINCIPAL OFFICE
