ARTICLES OF INCORPORATION
OF
BEAR FALLS PRESERVE, INC.

The undersigned, acting as incorporator of BEAR FALLS PRESERVE, INC. (the "Corporation") under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the Corporation is: BEAR FALLS PRESERVE, INC.

ARTICLE II

INDEMNIFICATION

The Corporation shall reimburse each person for all costs and expenses, including attorneys' fees, reasonably incurred by him or her in connection with any such liability in the manner provided for by law or in accordance with the Corporation's Bylaws.

The rights accruing to any person under the foregoing provision shall not exclude any other right to which he or she may be lawfully entitled, nor shall anything therein contain or restrict the right of the Corporation to indemnify or reimburse such person in any proper case even though not specifically provided for herein.
