Please Mr. Russ, I will appreciate you clear this situation and please send me the answer.

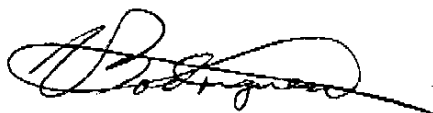
