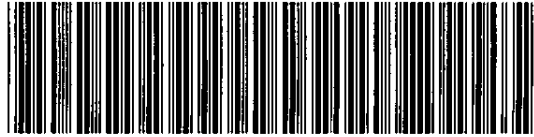

All other Articles unchanged.




