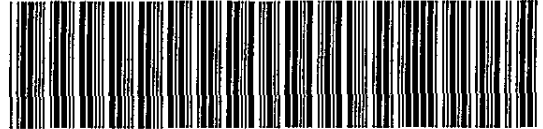

The Director and Shareholders wish to accept the appointment of TERESITA LUGO as a Director, Officer and Shareholder of the Corporation.

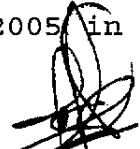
The Director and Shareholders wish to accept the resignation of LUIS LOPEZ as a Director, Officer and Shareholder of the Corporation.

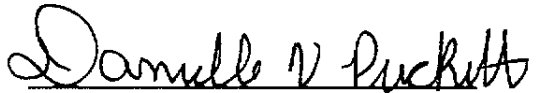
