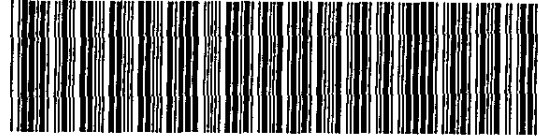

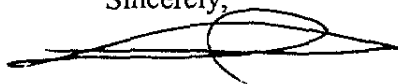

Each share certificate issued by the corporation shall have printed or stamped the following legend:

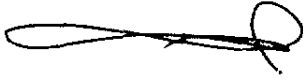
