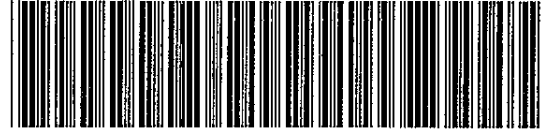

ARTICLE I. NAME

The name of this corporation is

This corporation shall commence January 1, 2005 and
