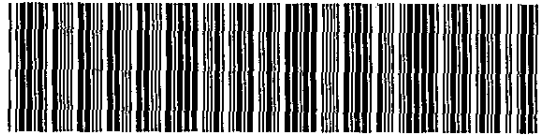

ARTICLE I. CORPORATION NAME



ARTICLE IX. AMENDMENT


