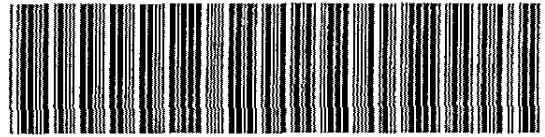

ARTICLE OF INCORPORATION

OF
