ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of the corporation is C. Lewis Realty, Inc., at 1249 Dawn Street NE, Palm Bay, FL 32905 (Principal Office of Registered Agent).

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.
