The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

## ARTICLE I - Name

The name of the corporation is CASEY MANAGEMENT GROUP, INC.

# ARTICLE II - Principal Office and Mailing Address of the Corporation

The address of the principal office of the corporation is 226 North Kentucky Avenue, Lakeland, Florida 33801, and its mailing address is the same.

#### **ARTICLE III - Commencement and Duration**

The corporation is to commence its corporate existence effective immediately, and shall exist perpetually thereafter until dissolved according to law.

#### **ARTICLE IV - Purpose**
