## ARTICLES OF INCORPORATION

# FOR PROFESSIONAL ASSOCIATION

OF

# BLAKE E. MOORES, D.D.S., P.A.

The undersigned natural person, competent and licensed to practice dentistry in the State of Florida, acting hereby as Incorporator for the purpose of forming a Professional Service Corporation for profit under the provision of Section 607, Florida Business Corporation Act, and Section 621, Florida Professional Service Corporation Act, of the Florida Statutes, does hereby adopt the following Articles of Incorporation:

#### ARTICLE I

### NAME OF CORPORATION, PRINCIPAL OFFICE AND MAILING ADDRESS

Blake E. Moores, D.D.S., P.A., shall be the name of this Corporation. The principal place of business and mailing address of the Corporation shall be: 1831 N. Belcher Road, Suite F-3, Clearwater, Florida 33765.

#### ARTICLE II

#### **PURPOSES**

The general nature and purposes of business to be transacted, promoted and carried on by the Corporation are as follows:

- A. To engage in every aspect in the practice of dentistry, and all its fields of specializations, as are engaged in by dentists.
- B. To engage and render the professional services involved only through its officers, agents and employees who shall be dentists in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional service as this Corporation.
- C. To invest its funds in real estate, mortgages, stocks, bonds and any other type of investments permitted by law.
- D. To engage in no other business other than the rendition of the professional services specified herein.

E. To do everything necessary and proper in accomplishing the purposes herein set forth and to do anything incidental thereto which is not forbidden under the laws of the State of Florida.

## ARTICLE III

#### CAPITAL STOCK

- A. The maximum number of shares of stock that the Corporation is authorized to have outstanding at any time shall be 10,000 shares of common stock at \$1.00 per share par value.
- B. The consideration to be paid for each share shall be payable in lawful money or property, labor or services.
- C. Shares of the Corporation's stock and certificates shall be issued only to dentists in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as this Corporation.
