### ARTICLES OF INCORPORATION OF PREMIER INTERIM COMPANY

The undersigned, acting as directors for the purpose of forming a corporation under and by virtue of the Laws of the State of Florida, adopts the following Articles of Incorporation.

#### ARTICLE I

The name of the corporation shall be Premier Interim Company and its initial place of business shall be 3110 Capital Circle NE, City of Tallahassee, in the County of Leon, and the State of Florida.
