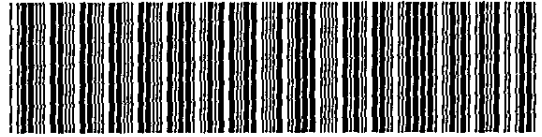

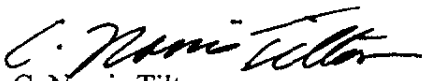

The undersigned Incorporator of these Articles of Incorporation, being a natural person competent to contract, hereby forms a Corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be: **PATRICK FLANAGAN ELECTRIC, INC.**

The initial principal place of business of this corporation shall be: 1612 Grapeland Avenue, Pt. St. Lucie, Florida 34952.

ARTICLE II - NATURE OF BUSINESS

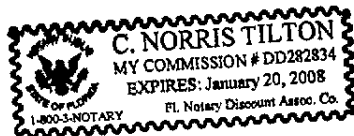
