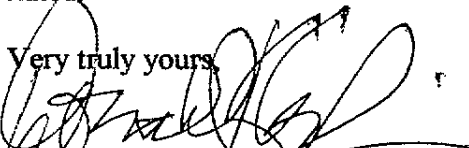

ARTICLE ONE

The name of the corporation is SUNNYLAND INDUSTRIAL PROPERTIES, INC., A FLORIDA CORPORATION. The initial office address of the corporation is 1450 SOUTH DIXIE HIGHWAY, Pompano Beach, Florida 33060.

The duration of the corporation is perpetual.
