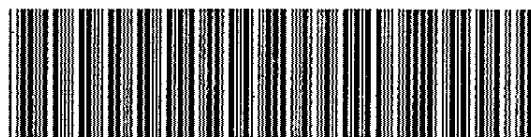


ARTICLE XI


