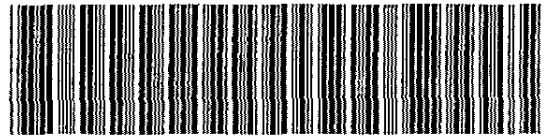



ARTICLE I. CORPORATE NAME

The name of this corporation is, **PROTENDER BARTENDING SCHOOLS, INC.**

ARTICLE II. NATURE OF BUSINESS AND POWERS

The nature of this business is a bartending school, and to conduct all business lawfully permitted under the Laws of The State of Florida and the United States.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is One Hundred (100) shares of capital stock having a par value of One Dollar (\$1.00) per share. Capital stock shall be the only class of stock this corporation shall have the authority to issue.



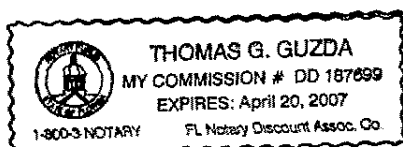


