The undersigned subscriber of these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

# ARTICLE I

#### Name

The name of this Corporation is YOUR ANIMAL'S HOUSE, INC.

# ARTICLE II

# Nature of Business

The general nature of the business to be transacted by this corporation is animal care and any other lawful business.

# ARTICLE III

#### Share of Stock

The total number of shares of stock which the corporation shall have the authority to issue is One Thousand (1,000) Shares, all of which shares shall have a par value of One Dollar (\$1.00) and shall have equal rights, privileges and voting power, unless other wise agreed upon.
