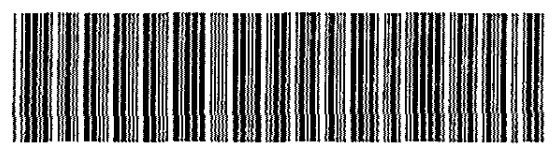

The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I
NAME

The name of this corporation is International K-9, Inc.

ARTICLE II
PRINCIPAL OFFICE/MAILING ADDRESS

The principal office and mailing address of the corporation is 1820 West 79th Street, Hialeah, Florida 33014.

ARTICLE III
SHARES

The number of shares the corporation is authorized to issue is 1000 shares par value of \$1.00 per share.

PREEMPTIVE RIGHTS

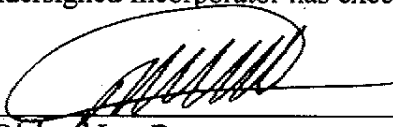

The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.

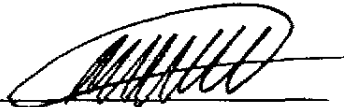
