ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF LET'S EAT WEST CHASE, INC.

Pursuant to Section 607,1003 and 607,1006 of the Florida Business Corporation Act, the Articles of Incorporation of Let's Eat Westchase, Inc. (the "Corporation"), are amended according to these Articles of Amendment:
