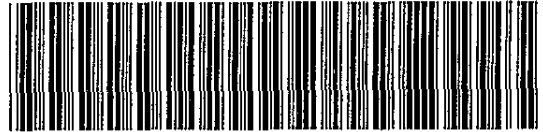

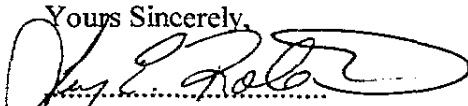

ARTICLES OF INCORPORATION

OF

R. M. R HEALTHCARE FACILITIES CONSULTING, INC.

The undersigned incorporator, being a natural person over the age of (18) years hereby make, subscribe, acknowledge, execute and file with the Department of State these ARTICLES OF INCORPORATION for the purpose of forming a Corporation for profit in accordance with the Laws of the State of Florida.

Article I...Name

The name of the Corporation is R. M. R. HEALTHCARE FACILITIES CONSULTING, INC.

Article II....Principal office

The principal office and mailing address is 6614 West Richard Dr. Spring Hill, FL. 34607, but this corporation shall have the power to move the principal office to any other address in the State of Florida and to establish branch offices at such other places within or without the State of Florida that may be deemed expedient.

Article III...Perpetual Existence

The Corporation shall have perpetual existence unless sooner dissolved by law.

Article IV... Nature of business

The general nature of the business to be transacted by this corporation will be to engage in Healthcare Facilities Consulting and any activity or business permitted under the laws of the United States and of this State.

Article V... Capital Stock

Article VI...Initial Capital

The amount of capital with which this corporation shall begin business shall be no less than Five Hundred (500) Dollars.

Article VII...Board of Directors

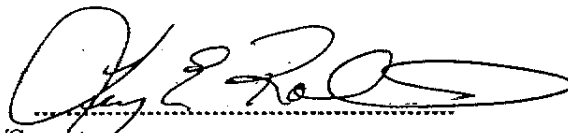
The shareholders of this corporation shall act in lieu of a Board of Directors , and all the powers , privileges, duties and responsibilities that otherwise would apply to the directors of the company shall instead apply to, be exercised by, and be attached to the shareholders of the company.
