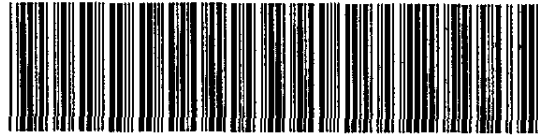

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is: 142B Whitaker Road Corporation.

ARTICLE II

The street address of the principal office of the Corporation is: 142B Whitaker Rd., Lutz, FL 33549.

ARTICLE III

The maximum number of shares this Corporation is authorized to issue is 10,000, par value \$1 per share, all of which shall be Common Shares.




